HEREBY MAKE OATH AND SAY AS FOLLOWS:

1. I was President of R & A Coins, Inc., throughout the existence of such corporation. The facts and information herein are therefore known to me personally or were obtained from company files and records to which I have access.


2. R & A Coins, Inc. is the registered owner of the United States trademark registration for the trademark **RA (Stylized)**, Reg. No. 1,725,469, registered October 20, 1992.
