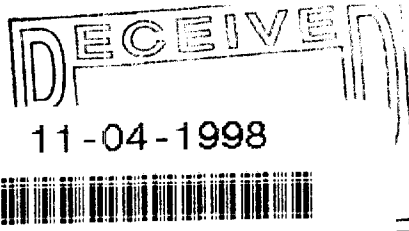

WHEREAS, Assignor has since used the mark and has filed an allegation of use under § 1(d) of The Trademark Act in the above-identified application; and


