TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is made the 23rd day of October 1993 BETWEEN ROTHMANS INTERNATIONAL ENTERPRISES LIMITED (formerly ROTHMANS INTERNATIONAL HOLDINGS (UK) LIMITED, formerly NEW TOBACCO (UK) LIMITED) (hereinafter referred to as the "Assignor"), a company incorporated under the laws of England with offices at 15 Hill Street, London W1X 7FB and DUNHILL TOBACCO OF LONDON LIMITED (formerly DUNHILL CIGARETTES OF LONDON LTD) (hereinafter referred to as the "Assignee"), a company incorporated under the laws of England with offices at 1a St James's Street, London SW1A 1EF.

WHEREAS the Assignor is the proprietor of all right, title and interest in and to the trade marks details of which are set out in the First Schedule hereto (hereinafter referred to as the "Trade Marks")

AND WHEREAS in this Assignment any reference to the "Trade Marks" and any reference to any goodwill or business is limited to the same in so far as they relate to the goods set out in the Second Schedule hereto (hereinafter referred to as "Tobacco Products")

NOW THEREFORE for good and valuable consideration the receipt of which is duly acknowledged:

the Assignor hereby assigns to the Assignee all right, title and interest in and to the Trade Marks including without limitation all registrations and pending applications in relation thereto TOGETHER WITH the goodwill of the business in which the Trade Marks are and/or have been used and the goodwill appurtenant to associated with and symbolised by the Trade Marks and all the rights which the Assignor may have acquired through the use and/or the reputation and/or the registration of any of the Trade Marks by or on behalf of the Assignor and/or predecessors of the Assignor and all rights of use and other benefits and advantages in any manner accruing to the Assignor and/or its predecessors, including without limitation, rights derived by reason of the use reputation and ownership of the Trade Marks which have or are deemed to have vested in or which have or which are deemed to have enured to the benefit of the Assignor and reserving unto itself all right, title and interest in and to the Dunhill Word Trade Mark in so far as the same relates to goods other than Tobacco Products.


