

ASSIGNMENT OF TRADEMARKS (this "Assignment") dated as of October 30, 1998 made by EWH 1979 DEVELOPMENT COMPANY, L.P., a California limited partnership, having an address c/o TrizecHahn Centers Inc., 4350 La Jolla Village Drive, Suite 700, San Diego, California 92122-1233 ("Assignor"), to NORTH COUNTY FAIR LLC, a Delaware limited liability company, having an address at c/o Westfield Corporation, Inc., 11601 Wilshire Blvd. 12th Floor, Los Angeles, California 90025- 1740 ("Assignee").

WHEREAS, Assignor has adopted, used and is using certain tradenames, servicemarks, tradedress, logos and trademarks, whether or not registered, including all common law rights thereto, relating to the property known as North County Fair, Escondido, California and more particularly described on Exhibit A attached hereto and made a part hereof (the "Property") (collectively, the "Assigned Marks") including, without limitation, the marks set forth on Schedule I hereto and incorporated by reference herein which are registered in, or for which application for registration has been filed in, the United States Patent and Trademark Office;

WHEREAS, Assignee desires to purchase or acquire Assignor's fifty five percent (55%) undivided interest as a tenant-in-common, being all Assignor's right, title and interest in and to the Assigned Marks;

WHEREAS, Assignor desires to execute and deliver this Assignment to Assignee; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor does hereby sell, transfer, convey, assign and deliver to Assignee Assignor's fifty five percent (55%) undivided interest as a tenant-in-common, being all right, title and interest of Assignor in and to the Assigned Marks, the registrations and applications for registrations thereof, and the goodwill of the business connected with the use thereof and symbolized thereby, all rights of priority therein in any country as may now or hereafter be granted to it by law, treaty or other international convention, and all rights, interests, claims and demands recoverable in law and equity that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Marks, including, without limitation, the right to compromise, sue for and collect such profits and damages, the same to be held and enjoyed by Assignee, its successors and assigns or its legal representatives, as tenant-in-common, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby agrees that Assignor shall and shall cause each of its affiliates to, from time to time, execute and deliver to Assignee such additional instruments, documents, conveyances or assurances and take such other action as shall be necessary or otherwise reasonably requested by Assignee to confirm and assure the rights and obligations provided for in

Except as set forth in the Asset Purchase Agreement, dated as of April 6, 1998, among TrizecHahn Centers Inc., Westfield America, Inc. and The Rouse Company, as amended, this Assignment is made without representation or warranty by, or recourse against, Assignor of any kind whatsoever.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to federal trademark issues, the laws of the State where the Property is located with respect to state trademark issues and, in all other respects including as to validity, interpretation and effect, by the laws of the State of New York, without giving effect to the conflict of laws rules thereof.

This Assignment may be executed in any number of counterparts all of which taken together shall constitute one and the same instrument.
