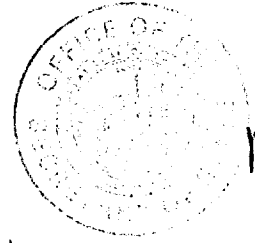

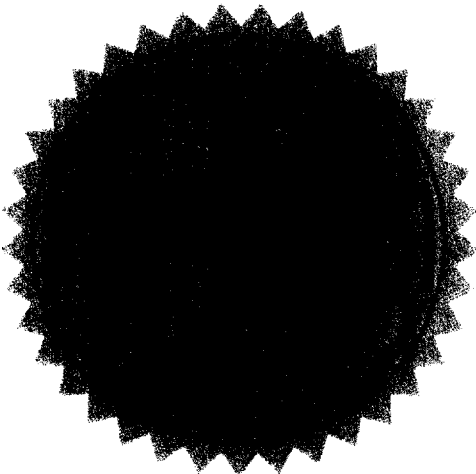

2. Article I of the Articles of Incorporation of this corporation is hereby amended to read in its entirety as follows:

"The name of the corporation is RightWorks Corporation."

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Sections 902 of the Corporations Code. The total number of outstanding shares of the corporation is 9,091,902 shares of Common Stock, 3,000,000 shares of Series A Preferred Stock, 4,946,000 shares of Series B Preferred Stock, 9,139,485 shares of Series C Preferred Stock and 7,838,085 shares of Series D Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the shares of Common Stock and Series A, Series B, Series C and Series D Preferred Stock.
