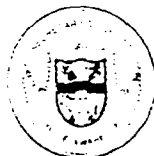

FIRST: The name of the Corporation is Frye Coypsystems, Inc.

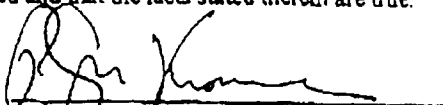
SECOND: The Certificate of Incorporation was filed by the Secretary of State on the 15th day of November, 1972.
