TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Fairbanks Scales Inc., a corporation formed under the laws of the State of Kansas, located at 821 Locust, Kansas City, Missouri 64106 ("Fairbanks"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Fairbanks and Thurman Scale Company (together with Fairbanks, each a "Borrower" and jointly and severally, the "Borrowers") are obligated to PNC Bank, National Association ("PNC") and various financial institutions (together with PNC, collectively, the "Lenders") named in or which hereafter become a party to the Loan Agreement (as hereafter defined) and PNC as agent for Lenders (PNC in such capacity, "Agent"), pursuant to (i) a certain Revolving Credit, Term Loan, Capital Expenditure Loan and Security Agreement, dated as of the date hereof, among Agent, Lenders and Borrowers and (ii) a certain Trademark Collateral Security Agreement, dated as of the date hereof, made by Fairbanks in favor of Agent for the ratable benefit of Lenders (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Fairbanks is granting to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Marks, the goodwill of the business for its benefit and symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Fairbanks does hereby assign unto Agent for its benefit and for the ratable benefit of Lenders and grant to Agent for its benefit and for the ratable benefit of Lenders a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.




