Certificate of Amendment of the Certificate of Incorporation of

NEW YORK ENVELOPE CORP.

under Section 805 of the Business Corporation Law

IT IS HEREBY CERTIFIED THAT:

(1) The name of the corporation is New York Envelope Corp., originally incorporated as New York Envelope Manufacturing Co., Inc.

(2) The certificate of incorporation was filed by the department of state on the 16th day of May 1951.

A certificate of change of name was filed by the department of state on the 19th day of March, 1952.

(3) The certificate of incorporation of this corporation is hereby amended to effect the following change:

1. To change the name of the corporation from New York Envelope Corp. to National Envelope Corporation and

2. To change the post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him

and to that effect.

Article First is amended to read as follows:

"First - The name of the corporation is National Envelope Corporation."

and

Article Fourth is amended to read as follows:

"Fourth - The Secretary of State is designated as agent of the corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him is:

Moser & Moser, 50 Broadway, New York, New York 10004."

Your letter to Nathan Moser dated July 27, 1998 with respect to the above-captioned trademark was referred to us for our attention.

In this connection, I wish to advise you that the mark was not assigned or transferred by New York Envelope Corp. to National Envelope Corporation. The disparity of name results from a change of the corporate name of New York Envelope Corp. to National Envelope Corporation. A copy of the Certificate of Amendment changing the corporate name which was filed in the Office of the Secretary of State of the State of New York on November 18, 1993 is herewith enclosed.
