RELEASE OF SECURITY INTEREST - TRADEMARKS

WHEREAS, Binks Sames Corporation (f/k/a Binks Manufacturing Company), a Delaware corporation ("Borrower"), The First National Bank of Chicago, as Collateral Agent (the "Agent") and the Lenders (as such terms are defined in the Credit Agreement hereafter referenced) are parties to that certain Amended and Restated Credit Agreement as of March 16, 1998;

WHEREAS, pursuant to the Trademark Security Agreement, the Borrower granted a security interest in favor of the Agent in the Trademarks and Licenses (as such terms are defined in the Trademark Security Agreement) including the trademarks, trademark and service marks applications, and license agreements listed on Schedule A and Schedule B attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office in the trademark assignment records on March 20, 1998 at Reel 1712, Frame 0946, a copy of which is attached hereto as Schedule A;

WHEREAS, the Agent desires to release its security interest and waive all of its rights in such Trademarks and Licenses, including the trademarks, trademark and service marks applications, and license agreements listed on Schedule A and Schedule B of the Trademark Security Agreement;

NOW THEREFORE, the Agent hereby releases its security interest and liens and waives all of its rights in such Trademarks and Licenses, including the trademarks, trademark and service marks applications, and license agreements listed on Schedule A and Schedule B attached hereto.



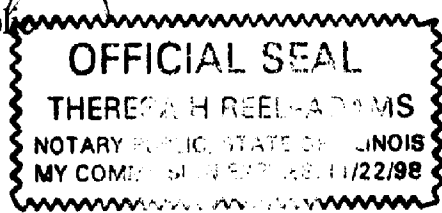
