ASSIGNMENT

On this 30th day of November, 1998,



Mark is used and all convention and treaty rights of all kinds in all countries of the world with respect to the foregoing, all the aforementioned property and rights to be held and enjoyed by M.G. Corp. for its own use, benefit and behalf and for the use, benefit and behalf of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by P.S., Inc. prior to this Assignment together with all claims for damages by reason of past infringement of said Mark and with the right to sue for and collect the same.


REPRESENTATION AND WARRANTIES

As an inducement to M.G. Corp. to purchase the "Mattress Magic" mark, U.S. Registration No. 2,123,959, P.S., Inc. hereby represents and warrants to M.G. Corp. that, to the best of P.S., Inc.'s knowledge, the Mark is subsisting and is not invalid or unenforceable, in whole or in part; and to the best of P.S., Inc.'s knowledge, P.S., Inc.'s use of the Mark is exclusive throughout the United States and does not infringe any rights owned or possessed by any third party; and neither P.S., Inc., nor, to the best of P.S., Inc.'s knowledge, any prior owner of the Mark, assigned or granted any rights or licenses to any person or entity which have not been terminated prior to the date hereof, nor has P.S., Inc. otherwise encumbered the Mark or any rights or interest therein. To the best of P.S., Inc.'s knowledge, it is the sole owner of the Mark, which is free and clear of any liens, charges and encumbrances, and no other person or entity has or shall have any claim of ownership with respect to the Mark. Moreover, P.S., Inc. warrants that it has the full right, power and authority to enter into this Agreement and assign, transfer and sell all of the right, title and interest in and to the Mark. P.S., Inc. further represents that there are no claims, judgements or settlements to be paid by P.S., Inc. or, to the best of P.S., Inc.'s knowledge, any pending claims or litigation, by or against P.S., Inc. or any prior owner of the Mark, relating to the Mark.
