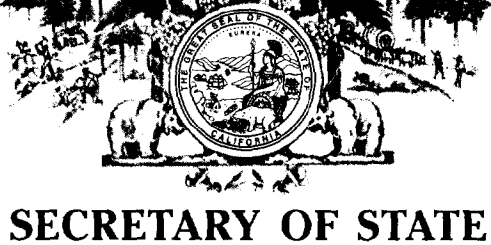

1. That they are President and Secretary, respectively,

2. That by unanimous written consent of the Board of

FIRST: The name of this corporation is:





