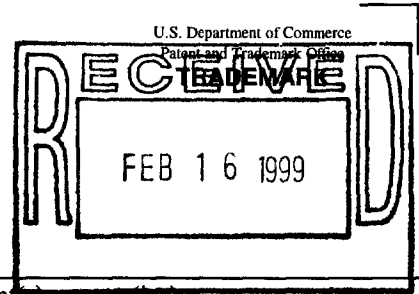

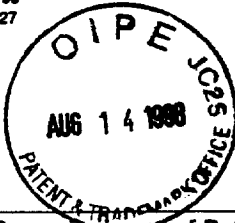


REQUEST FOR CORRECTION OF ASSIGNMENT DOCUMENT
