**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Release of Security Interest in Trademarks (the "Release"), dated as of February 23, 1999, is made by Nationsbank, N.A. (as successor in interest to Bank South, N.A.), a national banking corporation organized under the laws of the United States of America (the "Bank") in favor of Peachtree Software, Inc. (formerly Peachtree Software, L.P.), a corporation organized under the laws of the State of Delaware (the "Borrower").

WHEREAS, Borrower entered into a Security Agreement (the "Security Agreement"), dated as of November 1, 1988 and recorded in the Patent and Trademark Office as of November 14, 1988 at Reel/Frame 0628/0644, pursuant to which Borrower granted a security interest to the Bank in the trademarks set forth on Schedule A attached hereto (the "Released Trademarks"), to secure the performance of Borrower's obligations under the Loan Agreement (the "Loan Agreement") dated as of November 1, 1988 between the Bank and the Borrower;

WHEREAS, as of April 5, 1994, the Loan Agreement and the Security Agreement have been terminated and no amounts are owed by the Borrower to the Bank and the Bank has released any and all interest it may have in the Released Trademarks; and

WHEREAS, Borrower has requested that the Bank execute this Release for purposes of recording with the Patent and Trademark Office.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, and pursuant to the Security Agreement, the Bank does hereby confirm its previous release, relinquishment and discharge of its security interest in, to and under the Released Trademarks, and to the extent not previously released, relinquished and discharged, hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Bank has caused this Release to be duly executed as of the date hereinabove set forth.

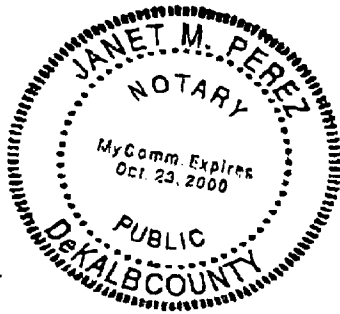
