RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("this Release") is made as of the 1 day of January, 1999, by FLEET PRECIOUS METALS INC. and FLEET NATIONAL BANK (jointly and severally, "Lenders") in favor of ARDIAN JEWELRY CORP., a New York corporation with a principal place of business 70 Randall Avenue, Rockville Centre, New York (the "Company").

WITNESSETH:

WHEREAS, pursuant to a certain Assignment of Trademarks and Tradenames dated as of June 27, 1997 and recorded with the U.S. Patent and Trademark Office on August 18, 1997 at reel 1623/frame 707 (the "Assignment"), the Company assigned and transferred and granted a lien and security interest in certain trademarks and service marks (as described in the Assignment, and the exhibits thereto) (collectively the "Intellectual Property") unto the Lenders as security for performance by the Company, Klein Jewelry Co., Inc. and Noble Jewelry, Inc. of their obligations under certain agreements; and

WHEREAS, each of the Lenders has agreed to release its security interest in and lien upon the Intellectual Property to the Company:

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, the Lenders and the Company hereby agree as follows:

1. Each of the Lenders hereby releases its security interest in the Intellectual Property, together with the goodwill associated therewith.
2. Each of the Lenders hereby assigns and transfers to the Company, without recourse or warranty, its entire right, title and interest in to and to the Intellectual Property, together with the goodwill associated therewith.
3. Each of the Lenders hereby acknowledges and agrees that the Assignment is terminated as of the date of this Release.
4. This Release is and shall be deemed to be a contract entered into and made pursuant to the laws of the State of Rhode Island and shall in all respects be governed, construed, applied and enforced in accordance with the laws of the State of Rhode Island, without reference to its conflicts of laws principles.
5. This Release may be executed in one or more counterparts hereof, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
