ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
PERSONNEL CONCEPTS, INC.



Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The current name of the corporation is Personnel Concepts, Inc. The new name of the corporation as amended hereby is **FRANLINK, INC.**

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on December 22, 1998.

The Amendment alters Article One of the original Articles of Incorporation and the full text of each provision added is as follows:

"ARTICLE ONE

The name of the corporation is **FRANLINK, INC.**"

ARTICLE III

The number of shares of the Corporation outstanding at the time of such adoption was 3,000, the holders of all of which are entitled to vote on the adoption of the amendment provided herein and have unanimously consented in writing to such adoption.
