

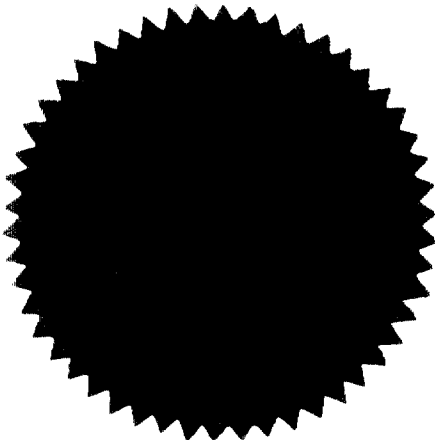

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation, hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

2. The following amendment to the articles of incorporation of the corporation was adopted by its shareholders on the 3rd day of November, 1997, in the manner prescribed by law:


RESOLVED that the Articles of Incorporation of the company be amended by striking Article 1 thereof and substituting the following in lieu thereof:
