REED ELSEVIER PROPERTIES INC."



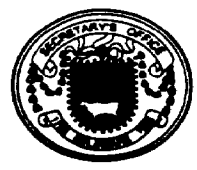
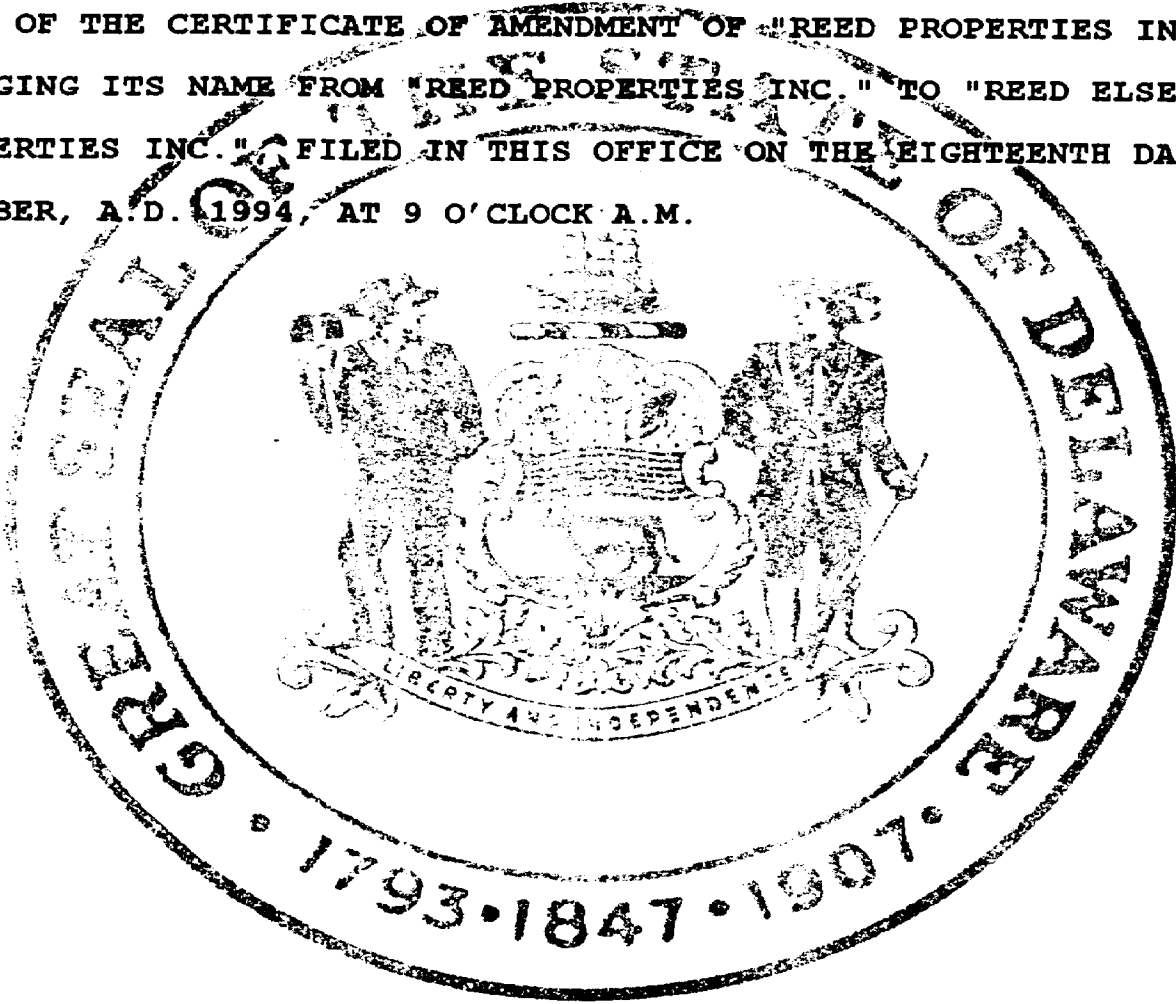
