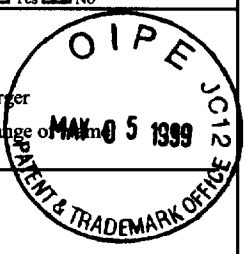

ASSIGNMENT

Date: 30 MARCH 1999

Parties:

(1) 'The Assignor': SCAPA TAPES PLC (formerly Rotunda plc), Company Registration No. 233167, of Holland Street, Denton, Manchester, M34 3GH, England;

(2) 'The Assignee': SCAPA TAPES UK LIMITED, Company Registration No. 3261510, of Holland Street, Denton, Manchester, M34 3GH, England.

Recitals:

(A) The Assignor is the registered proprietor of the Registered Trade Marks particulars of which are set out in Schedule 1 below hereto and the applicant for registration of the Trade Marks particulars of which are set out in Schedule 2 below (collectively called 'the Trade Marks').

(B) The Assignor has agreed to assign to the Assignee the Trade Marks together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered or registration has been sought upon the terms and conditions hereinafter, appearing.

Operative provisions:

1. Assignment

In pursuance of the said agreement and in consideration of the sum of £1.00 (one pound sterling), now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) the Assignor HEREBY ASSIGNS unto the Assignee the Trade Marks and the full and exclusive benefit of each of them together with all rights and powers arising or accrued from such Trade Marks, including the right to sue for damages and other remedies and to have the benefit of any remedy obtained on any supposed infringement of the Trade Marks before the date of this assignment, and the goodwill of the business of the Assignor concerned in the goods or services in respect of which the Trade Marks are registered or registration has been sought TO HOLD the same unto the Assignee absolutely.

2. Assignor's obligations.

The Assignor shall at the discretion and expense of the Assignee execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as proprietor of the Trade Marks and to secure the benefits of the rights hereby assigned.


