

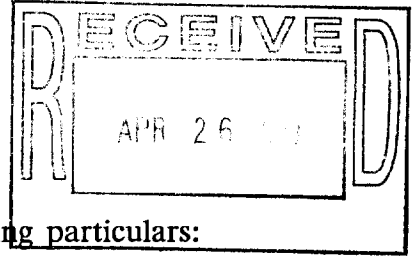

SECOND: The Certificate of Incorporation of the Company was originally filed with the Secretary of State of the State of Delaware on June 29, 1995.

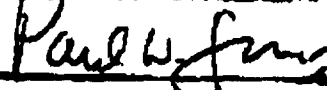

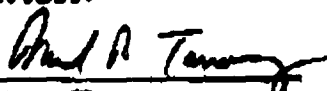
