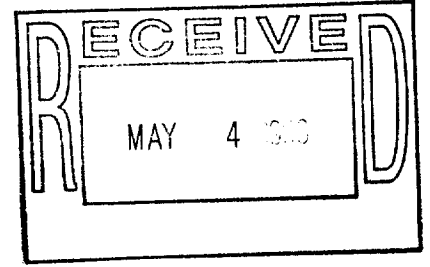



TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into as of the 30th day of June, 1998 by and between Navigator Publishing Corp., a Connecticut corporation with a place of business located at 18 Danforth Street, Portland, Maine (the "Assignor") and Navigator Publishing LLC, a Delaware limited liability company (the "Assignee") with a principal place of business in Portland, Maine.

WITNESSETH:

WHEREAS, the Assignor and the Assignee have entered into an Asset Purchase Agreement dated March 31, 1998 (the "Agreement") pursuant to which the Assignee will purchase from the Assignor substantially all of the assets of the Assignor and assume the Assumed Contracts and Assumed Liabilities; and

WHEREAS, among the assets being purchased are all of the Assignor's Intellectual Property, as that term is defined in the Agreement, including the trademarks listed in Schedule A attached hereto (the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the Assignor hereby assigns, conveys and transfers to the Assignee all of its right, title and interest to the following:

1. The Trademarks, whether registered or unregistered, including any registrations of the aforesaid trademarks, together with all of the goodwill of the business of the goods and services for which the Trademarks are registered and/or used and all

common law rights thereto, and including all rights in licenses and agreements connected with the use of the Trademarks and other properties and rights related thereto.

2. The right to sue and recover for damages and profits and all remedies for past infringements of the Trademarks and other properties and rights transferred herein.

3. Assignor undertakes, at the request of Assignee, to execute all reasonable documentation, including confirmatory trademarks assignments or other documents, and generally do everything necessary and proper subsequent to the signing of this Trademark Assignment in order to transfer to the Assignee full ownership of the Trademarks and the properties and rights with respect thereto.
