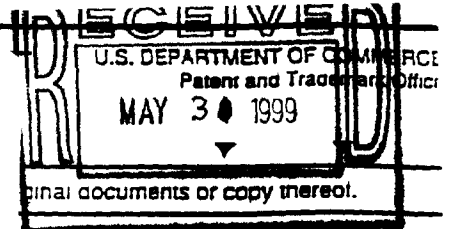

**WHEREAS**, Assignor and Assignee are parties to an Asset Purchase Agreement dated as of March 3, 1999 (the "Asset Purchase Agreement"), and it is a condition to the closing thereunder that Assignor execute and deliver, and in furtherance of the Asset Purchase Agreement Assignor does hereby execute and deliver, this Trademark and Tradename Assignment;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Marks and Tradename, together with the goodwill of the business appurtenant to and symbolized by the Marks and Tradename, and all its right, title and interest in and to the Service mark, including without limitation, all its rights under the Service mark License Agreement ("Service Mark License Agreement") dated as of August 7, 1998, between Assignor and Toray Ultrasuede (America), Inc., in perpetuity on a royalty-free basis, together with the goodwill of the business appurtenant to and symbolized by the Service mark.
