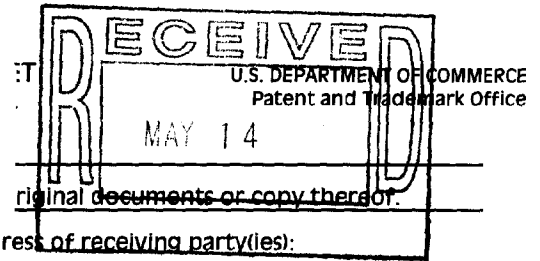

ARTICLES OF AMENDMENT TO THE CHARTER

OF

PARK MED, P.C.

TO THE SECRETARY OF STATE OF THE STATE OF TENNESSEE:

Pursuant to the provisions of Section 48-20-106 of the Tennessee Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its charter:


1. The name of the corporation is Park Med, P.C.
2. The text of the amendment adopted is as follows:
  - (a) The corporation hereby changes from a professional corporation to a general corporation; and
