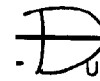

of the General Corporation Law of
the State of Delaware

DocuPro, Incorporated (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

FIRST: The Board of Directors of the Corporation adopted resolutions pursuant to Section 242 of the General Corporation Law of the State of Delaware at a meeting on August 31, 1998 pursuant to and in accordance with Sections 141 and 222 of the General Corporation Law of the State of Delaware, setting forth amendments to the Certificate of Incorporation (the "Certificate") and declaring said amendments to be advisable. The stockholders of the Corporation duly approved the proposed amendments in accordance with Section 242 of the General Corporation Law of the State of Delaware by written consent in lieu of a meeting pursuant to and in accordance with Section 228 of the General Corporation Law of the State of Delaware. The resolutions setting forth the amendments are as follows:

RESOLVED: That Article FIRST of the Certificate of Incorporation of the Corporation be and hereby is deleted in its entirety and replaced as follows:

"The name of the corporation is Mobeo, Inc."

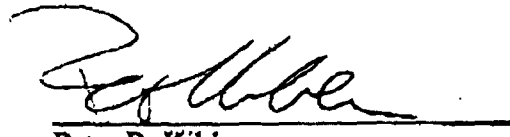
SECOND: This amendment to the Certificate of Incorporation shall be effective as of the date accepted for filing by the Secretary of State of the State of Delaware.
