

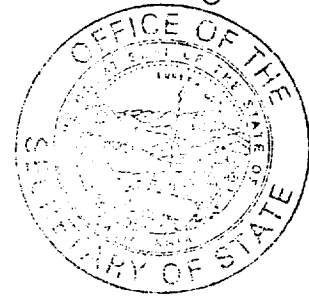
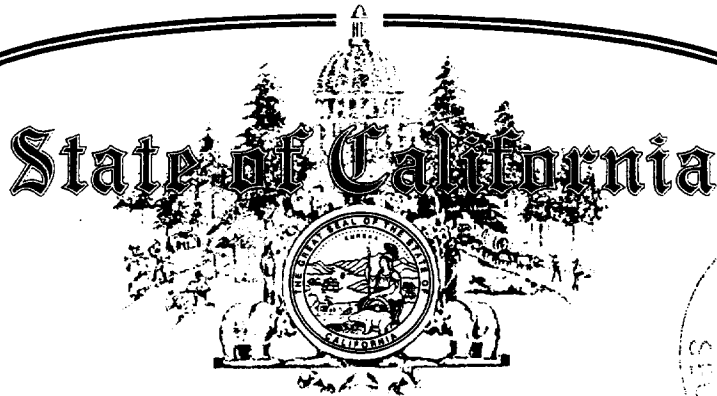

CERTIFICATE OF AMENDMENT OF
ARTICLES OF INCORPORATION OF
CAD.LAB, INC.

Joseph B. Costello and Robert P. Latta certify that:

1. They are the President and Assistant Secretary, respectively, of CAD.LAB Inc., a California corporation.

2. Article I of the Articles of Incorporation of this corporation is hereby amended to read in its entirety as follows:

"I

The name of the corporation is think3design.


3. The foregoing Certificate of Amendment of Articles of Incorporation has been duly approved by the Board of Directors.

4. The foregoing Certificate of Amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 and 903 of the Corporations Code. The authorized number of Common Stock is 50,000,000, of which 21,538,747 are issued and outstanding. The authorized number of Preferred Stock is 17,624,242, of which 7,624,242 shares are designated as Series A Preferred, all of which are issued and outstanding and 10,000,000 shares are designated as Series B Preferred, 9,768,095 of which are issued and outstanding. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the Common Stock, more than 50% of the Series A and more than 66% of the Series B Preferred Stock, voting as separate classes.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in the foregoing Certificate are true and correct of our own knowledge.
