

NOW, THEREFORE, in consideration of One Dollar (\$1.00), the consideration set forth in the Purchase and License Agreement dated May 1, 1999 by and amongst Shuffle Master, Inc., a corporation, and Derek Webb d/b/a Prime Table Games, a sole proprietorship, Derek Webb and Hannah O'Donnell, a partnership, Derek Webb, an individual, and Hannah O'Donnell, an individual, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Webb hereby sells, assigns and transfers to Shuffle Master, its successors and assigns, the entire right, title and interest in and to the mark "Three Card Design" and the U.S. Principal Registration thereof, Reg. No. 2,036,848 and the goodwill of the business pertaining thereto.

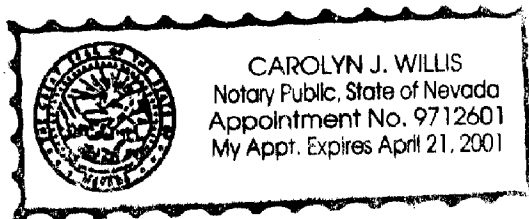
