FIRST: That this corporation was incorporated under the name
Moog Valve Co., Inc. on the 1st day of August, 1951, pursuant to the laws of the
State of New York.

SECOND: That this corporation owns all of the outstanding shares
of the stock of RAYTHEON AIRCRAFT MONTEK COMPANY, a corporation
incorporated on the 17th day of July, 1996, pursuant to the General Corporation
Code of the State of Kansas.

THIRD: That this corporation, by the following resolutions of its

RESOLVED, that MOOG INC. merge into itself RAYTHEON AIRCRAFT MONTEK COMPANY, and assume all of its obligations; and

FURTHER RESOLVED, that the merger shall become effective on November 30, 1998; and

FURTHER RESOLVED, that the proper officers of this corporation be and they hereby are directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge RAYTHEON AIRCRAFT MONTEK COMPANY into this corporation and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State of the State of Kansas, and to do all acts and things whatsoever, whether within or without the State of Kansas, which may be necessary or proper to effect said merger.

FOURTH: That this corporation survives the merger and may be served with process in the State of Kansas in any proceeding for enforcement of any obligation of RAYTHEON AIRCRAFT MONTEK COMPANY as well as for enforcement of any obligation of the surviving corporation arising from the merger, and it does hereby irrevocably appoint the Secretary of State of the State of Kansas as its agent of process to accept service of process in any such proceeding. FIFTH: Anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the board of directors of MOOG INC., at any time prior to the date of filing the merger with the Secretary of State.
