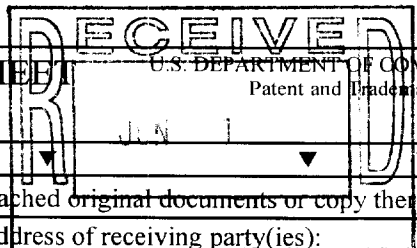

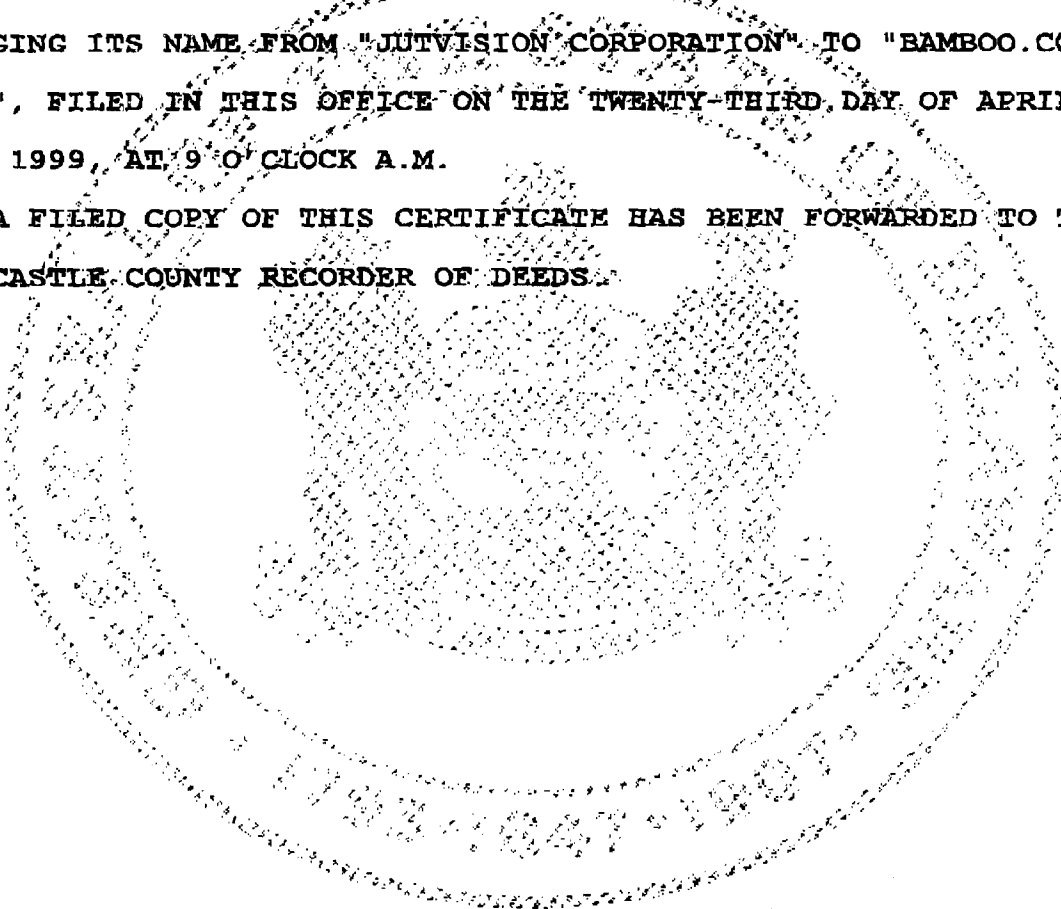

**CERTIFICATE OF AMENDMENT
OF THE AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF JUTVISION CORPORATION**

Jutvision Corporation, a corporation organized and existing under the laws of the State of Delaware, hereby certifies as follows:

A. The name of the corporation is Jutvision Corporation. The corporation was originally incorporated under the same name, and the original Certificate of Incorporation of the corporation was filed with the Secretary of State of the State of Delaware on March 26, 1998.

B. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment of the Amended and Restated Certificate of Incorporation amends the provisions of this corporation's Certificate of Incorporation as set forth herein.

C. Article ONE is hereby amended to read in its entirety as follows:

"ONE. That the name of the Corporation is: bamboo.com, Inc."

D. This Certificate of Amendment of the Amended and Restated Certificate of Incorporation has been duly adopted in accordance with the provisions of the General Corporation Law of the State of Delaware by the Board of Directors of the corporation.


E. The foregoing amendment of the Amended and Restated Certificate of Incorporation has been duly approved by the written consent of the stockholders in accordance with Sections 228 and 242 of the General Corporation Law. The total number of outstanding shares of Common Stock of the Corporation is 150,500. The total number of outstanding shares of Class B Common Stock of the Corporation is 2,650,548. The total number of outstanding shares of Series A Preferred Stock is 291,250. The total number of outstanding shares of Series B Preferred Stock is 2,152,568. The number of shares held by stockholders who consented to this amendment in writing equaled or exceeded the required percentage. Pursuant to Section 228 of the General Corporation Law, prompt written notice of this amendment has been given to all stockholders who did not consent to this amendment.

IN WITNESS WHEREOF, the Company has caused this Certificate of Amendment of the Amended and Restated Certificate of Incorporation to be signed by Leonard McCurdy, its Chief Executive Officer, effective as of April 14, 1999.
