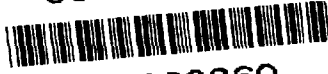

FSS Acquisition Corp. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Laws of the State of Delaware, does hereby certify and set forth that:

FIRST: The name of the Corporation is FSS Acquisition Corp.

SECOND: The Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on the 18th day of September, 1996.

THIRD: The Board of Directors of said Corporation adopted a resolution proposing and declaring advisable that the Certificate of Incorporation of the Corporation be amended as follows:

Article 1, relating to the name of the Corporation, is deleted in its entirety and the following is inserted in its place and stead:

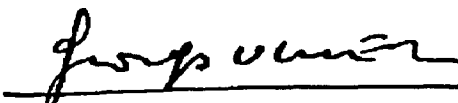
1. The name of the corporation is Farnam/Meillor Sealing Systems, Inc.
