

CERTIFICATE OF MERGER OF ENGLISHTOWN SPORTSWEAR LTD. INTO SEATTLE PACIFIC INDUSTRIES, INC. UNDER SECTION 907 OF THE BUSINESS CORPORATION LAW

- 1. The names of the corporations to be merged are Englishtown Sportswear Ltd., a New York corporation ("Englishtown"), and Seattle Pacific Industries, Inc., a Washington corporation. The name of the surviving corporation Seattle Pacific Industries, Inc. (the "Surviving Corporation"). Seattle Pacific Industries, Inc. was forced under the name Union Bay Sportswear, Ltd.
- 2. The issued and outstanding stock of Englishtown consists of forty shares of a single class of stock without par value, all of which are owned by the Surviving
- 3. The issued and outstanding stock of the Surviving Corporation consists of 8,622,000 shares of a single class of common stock, par value \$1.00 per share.
- 4. The merger is permitted by the laws of the State of Washington and is in compliance therewith.
- 5. The Surviving Corporation was incorporated under the laws of the State of Washington on December 10, 1980. The date the Surviving Corporation's application for authority to do husiness in the State of New York was filed by the Department of State was April 15, 1981.
- 6. The date on which the Certificate of Incorporation of Englishtown was filed by the State of New York Department of State was September 10, 1975.
- 7. The undersigned Surviving Corporation hereby agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability of or obligation of Englishtown, and for the enforcement, as provided in the New York Business Corporation Law (the "BCL"), of the right of shareholders of Englishtown to receive payment for their shares against the Surviving Corporation.
- 8. The undersigned Surviving Corporation further agrees, subject to the provisions of Section 623 of the BCL, that it will promptly pay to the shareholders of Englishtown the amount, if any, to which they shall be entitled under the

provisions of such chapter relating to the right of shareholders to receive payment for their shares.
