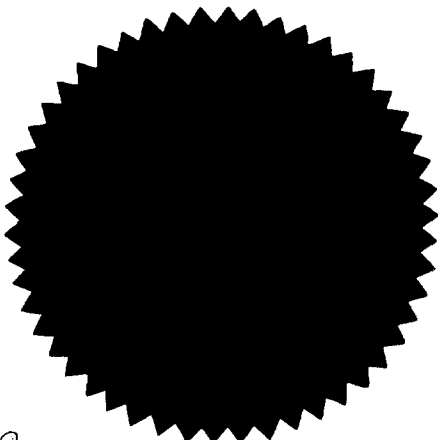

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation, as amended.

1. The name of the corporation is M & G Manufacturing Company.

2. The following amendment to the Articles of Incorporation, as amended, was adopted by the shareholders of the corporation, in the manner prescribed by the Iowa Business Corporation Act:

The Articles of Incorporation of the Company, as amended, are hereby amended by deleting Article I in its entirety and substituting the following in lieu thereof:

ARTICLE I

The name of the corporation is Monarch Manufacturing Company.

3. The date of adoption of the amendment was April 19, 1995.


4. The amendment was approved by the shareholders. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the amendment, and the number of votes of each voting group indisputably represented at the meeting is as follows:
