

Pursuant to Section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation, as amended.

- 1. The name of the corporation is M & G Manufacturing Company.
- 2. The following amendment to the Articles of Incorporation, as amended, was adopted by the shareholders of the corporation, in the manner prescribed by the Iowa Business Corporation Act:
