TRADEMARK ASSIGNMENT BY CORPORATION

This Assignment made this 22 day of OCT, 1997 from Caron International, Inc. a Delaware corporation, ("Assignor") to National Spinning Co., Inc., a New York Corporation, ("Assignee"), WITNESSETH:

WHEREAS, Assignor owns the U.S. trademark "PERFORMER," which as been registered in the U.S. Patent and Trademark office as U.S. Trademark Reg. No. 1,107,348 for yarns in International Class 23, which registration issued on November 28, 1978 (the "Mark"); and

WHEREAS, said parties are desirous of transferring all right, title and interest in and to the Mark from Assignor to Assignee,

NOW, THEREFORE, in consideration of the sum of \$1.00 and other good and valuable consideration paid by the Assignee to the Assignor, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers and conveys to the Assignee, its successors, assigns and other legal representatives, all rights, title and interest in the United States and throughout the world, in and to the Mark and the registration thereof, together with the goodwill of the business in connection with which the Mark is used, and further including all claims for damages by reason of past infringement of the Mark, with the right to sue for, and collect the same for Assignee's own use and benefit.

Whenever requested to do so by Assignee or its successors, assigns or other legal representatives, Assignor shall execute and deliver any and all assignments or other instruments which such requesting party shall deem necessary to more effectively complete the assignment of the Mark and to allow Assignee and its successors, assigns or other legal representatives to apply for and obtain renewal registration thereof or to otherwise protect their respective interests therein.

And the Assignor hereby covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement or assignment to conflict herewith.
