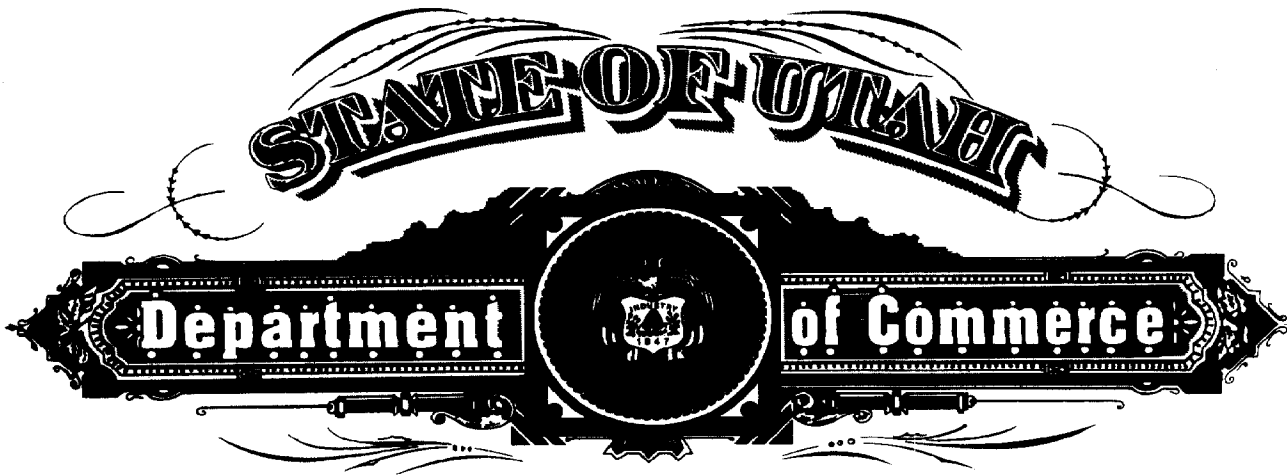

**ARTICLES OF AMENDMENT
for
TestOut! Corporation
(Formerly United Education Centers, Inc.)**



Pursuant to the Utah Revised Business Corporation Act, United Education Centers, Inc., a Utah Corporation (the "Corporation") hereby adopts the following Articles of Amendment to the Corporation's Articles of Incorporation.

Article I
Name

The name of the Corporation has heretofore been United Education Centers, Inc.

Article II
Amendment

The name of the Corporation, as designated in Article I of the original Articles of Incorporation, is hereby changed to TestOut! Corporation.

Article III
Date of Adoption

These articles of amendment are hereby adopted, effective this 26 day of October, 1998.

Article IV
Approval by Shareholders

The total number of shares of the Corporation's Class A--Voting stock which are outstanding are 10,000. All of such shares are entitled to vote on this Amendment, and were indisputably represented at the meeting at which this Amendment was approved.
