

ASSIGNMENT FOR SECURITY - TRADEMARKS

WHEREAS, PITTSBURGH BREWING COMPANY, a Delaware corporation, with its principal office at 3340 Liberty Avenue, Pittsburgh, PA, 15201 and with an office at 919 North Market Street, 2nd Floor, Wilmington, Delaware 19801-4921 (the "Assignor") has adopted, used and is using the trademarks listed on the annexed Schedule A, which trademarks are registered, to the extent indicated, in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Assignor is obligated to NATIONAL CITY BANK OF PENNSYLVANIA, with an office at 20 Stanwix Street, 19th Floor, Pittsburgh, Pennsylvania 15222 (the "Assignee") and has entered into a Trademark Security Agreement dated the same date of this Assignment, as the same may be amended, modified or supplemented from time to time (the "Trademark Security Agreement") in favor of Assignee; and

WHEREAS, pursuant to the Trademark Security Agreement and the Security Agreement dated June 24, 1997 (the "Security Agreement"), Assignor has assigned to Assignee, and granted to Assignee a mortgage on, pledge of and security interest in, all right, title and interest of Assignor in and to the Trademarks, together with the good will of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "Trademark Collateral") to secure the payment of the Indebtedness (as defined in the Trademark Security Agreement);


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound hereby, Assignor does hereby further assign unto Assignee and grant to Assignee a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment of the Indebtedness.


