## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

Release made as of June 30, 1999 (the "Release"), by Bank of America Corporation, a Delaware corporation (the "Secured Party"), in favor of Strombecker Corporation, an Illinois corporation (the "Debtor").

WHEREAS, the Debtor owns certain trademarks (the "Trademarks"), United States trademark registrations thereof (the "Registrations"), and United States trademark applications for the Trademarks (the "Applications"), all as more specifically identified on Exhibit A attached hereto.

WHEREAS, on or about November 13, 1997, the Secured Party obtained a security interest in the Trademarks in addition to any trademark rights acquired by the Debtor after November 13, 1997 (the "New Trademark Rights");

WHEREAS, some of the Applications in which the Secured Party obtained a security interest have matured into Registrations as of the execution of this Release, and are identified on Exhibit A;

WHEREAS, the Debtor has satisfied its debt owed to the Secured Party; and

WHEREAS, the Debtor desires such security interest to be released and terminated, and the Secured Party is willing to make such release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Secured Party hereby releases and terminates its lien upon and security interest in and to: the Trademarks and the New Trademark Rights together with the goodwill of the business symbolized by the Trademarks and the New Trademark Rights; all right, title and interest in and to the Trademarks and the New Trademark Rights; any licenses thereunder; all rights in the Registrations and the Applications; all rights to seek other registrations of the Trademarks and the

New Trademark Rights in the United States Patent and Trademark Office or elsewhere; and all causes of action, past and future, for infringement or other violations of the rights in the Trademarks and the New Trademark Rights.

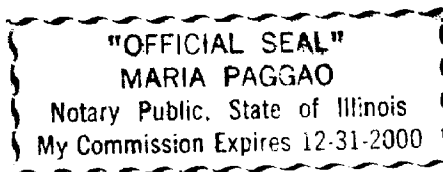
