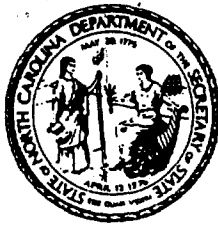

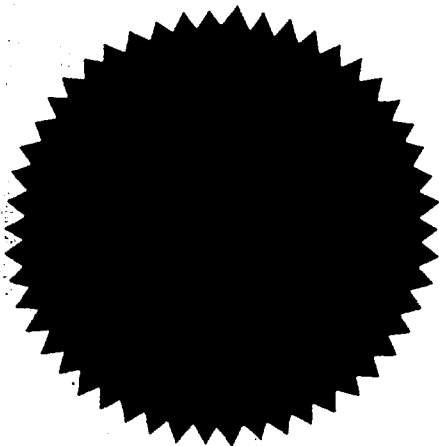

The undersigned corporation hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation:

1. The name of the corporation is Computrac, Inc.
2. The following amendment to the Articles of Incorporation of the corporation was adopted by its shareholders on the 23~~rd~~ day of April, 1996, in the manner prescribed by law:

The name of the corporation is amended to be "Cartbrella, Inc."

3. The number of shares of the corporation outstanding at the time of such adoption was ONE THOUSAND (1,000). The number of votes entitled to be cast thereon was ONE THOUSAND (1,000). The number of votes indisputably represented at the meeting of shareholders was ONE THOUSAND (1,000).
