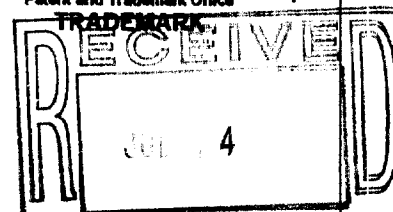

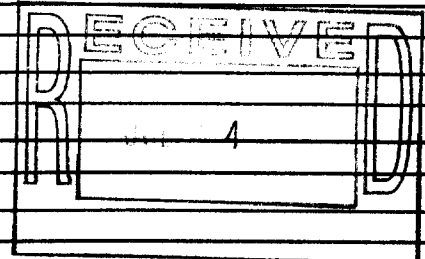

ASSIGNMENT OF TRADEMARKS


