RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT dated as of December 23, 1986 by Security Pacific Business Credit Inc. ("SPBC").

W I T N E S S E T H:

WHEREAS, SPBC and Crenlo, Inc. ("Company") are parties to a certain Loan and Security Agreement dated as of July 31, 1985 (the "Agreement") and a Collateral Patent, Trademark and License Assignment dated as of July 31, 1985 (the "Assignment"), recorded by the Assignment Division of the U.S. Patent and Trademark Office on October 7, 1985, Reel 4474, Frame 0175, pursuant to which the Company incurred certain obligations to SPBC and granted a security interest in and collateral assignment of certain patents and trademarks as described in Schedule A attached hereto (the "Patents and Trademarks"), among other things, as security for the Company's "Obligations" (as defined in the Agreement) to SPBC; and

WHEREAS, the Company intends to repay the Obligations and has requested that SPBC release its security interest in the Patents and Trademarks and reassign the same to the Company upon such repayment;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, and effective as of December 30, 1986 upon the repayment by the Company to SPBC of all of the Obligations:

1. SPBC hereby releases its security interest in and collateral assignment of the Patents and Trademarks.

2. SPBC hereby reassigns, grants and conveys to the Company, without any representation, recourse or undertaking by SPBC, all of SPBC's right, title and interest in and to:

(1) The Patents and Trademarks and (a) renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout

(ii) The goodwill connected with and symbolized by the Patents and Trademarks.

IN WITNESS WHEREOF, SPBC has caused this Release and Reassignment to be duly executed by its duly authorized officer as of the day and year first above written.
