

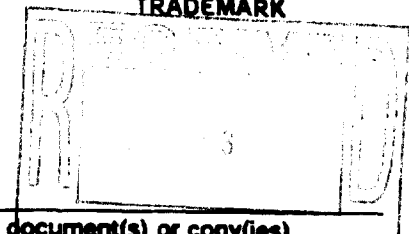

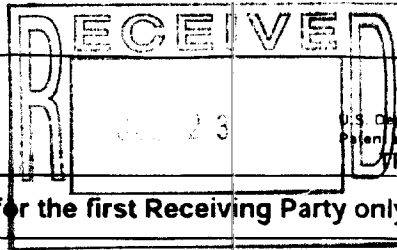

TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, made by and between Ralin Medical, Inc., a/k/a Ralin, Inc., a Delaware corporation ("Assignor"), and Lifewatch, Inc., a Delaware corporation ("Assignee").

Assignor authorizes and requests the Assistant Commissioner for Trademarks to record Assignee as the owner of the entire right, title and interest in and to the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute any agreement in conflict herewith.
