ASSIGNMENT OF TRADEMARK

WHEREAS, Quadramatic plc, a public limited company, incorporated under the laws of England and Wales having offices at Coin House, New Coin Street, Royton, Oldham OL2 6JZ, England (hereinafter referred to as the "Assignor") is the proprietor of the VIGILANCE trademark in the United States, which mark is the subject of US Application No. 75/494220 (the "Mark").

Assignor agrees, at Assignee's expense and request, to take all lawful acts which Assignee may deem advisable or necessary in order to render this assignment fully effective and to register and enforce the rights conveyed hereby, including without limitation, execution of lawful documents, and co-operation in production of evidence and giving of testimony in connection with proceedings to enforce the rights conveyed hereby.
