

ARTICLES OF AMENDMENT TO CHARTER OF OMNIVIEW, INC.

Pursuant to the provisions of § 48-20-106 of the Tennessee Business Corporation Act, the undersigned Corporation hereby submits these Articles of Amendment to its Amended and Restated Charter.

- 1 The name of the Corporation is Omniview, Inc.
- 2. The text of each amendment adopted is:
 - The name of the corporation is changed to Interactive Pictures Α. Corporation, consistent with the Corporation's reservation of such corporate name filed February 4, 1997 (Request No. 3283-1165).
 - Article 7 of the Amended and Restated Charter of the Corporation В. is amended to provide as follows:
 - 7. The number of shares that the Corporation is authorized to issue is twenty-five million (25,000,000) shares, with no par value.
- 3. The Corporation is a for-profit corporation.
- The amendment was duly adopted on March 7, 1997 by the shareholders and further ratified on March 27, 1997 by the shareholders.
- 5. The amendments set forth herein are to be effective when filed by the Secretary of State.
