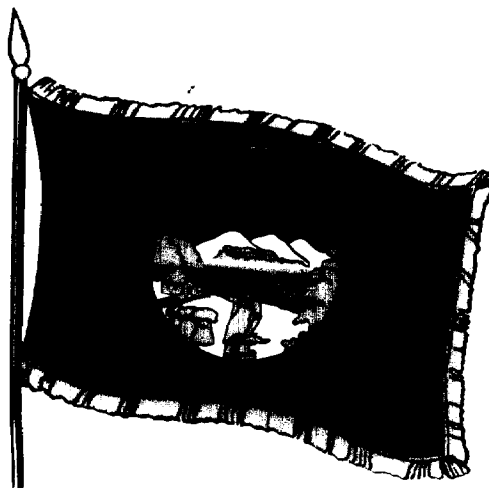

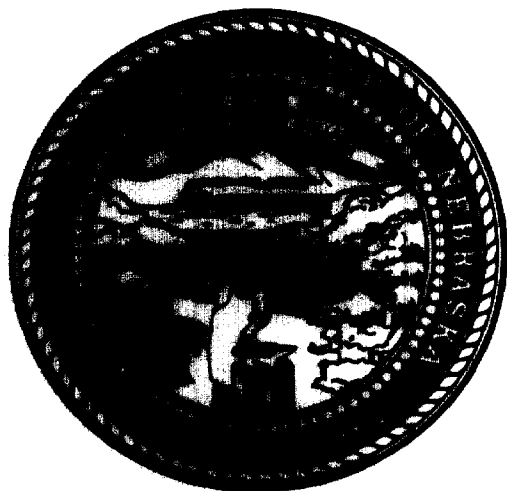

ARTICLES OF AMENDMENT OF  
ARTICLES OF INCORPORATION OF  
AMERITRADE CLEARING, INC.

Pursuant to the Business Corporation Act of  
AmeriTrade Clearing, Inc., a Nebraska corporation, executes the  
following Articles of Amendment of its Articles of Incorporation:

FIRST: The name of the corporation is AmeriTrade Clearing,  
Inc.

SECOND: Article I of the Articles of Incorporation of the  
corporation has been amended so as to read in its entirety as  
follows:

"ARTICLE I.

NAME

The name of the corporation is Advanced Clearing, Inc."

THIRD: Such amendment was adopted on the 13<sup>th</sup> day of  
January, 1998.

FOURTH: The designation and number of outstanding shares of  
the corporation are as follows:

<u>Designation</u>	<u>Number of Outstanding Shares</u>
Common Stock	7,559

The corporation has only one voting group.

FIFTH: Such amendment has been approved by a written consent
