FIRST AMENDMENT TO ASSIGNMENT OF INTELLECTUAL PROPERTY

This First Amendment To Assignment Of Intellectual Property is made and entered into by and between The Reynolds and Reynolds Company ("Reynolds"), an Ohio corporation, and Reynolds and Reynolds Holdings, Inc. ("Holdings"), an Ohio corporation.

WHEREAS, Reynolds and Holdings entered into an Assignment Of Intellectual Property effective January 20, 1998 whereby Reynolds assigned to Holdings all right, title and interest in and to its trademarks, service marks, trade names, trade dress, copyrighted works and inventions;

WHEREAS, the parties wish to amend said Assignment Of Intellectual Property to include the trademarks and service marks and Registrations and applications therefor identified on EXHIBIT A-1 attached hereto (the "Marks");

WHEREAS, the parties wish to amend said Assignment Of Intellectual Property to include the copyrighted works and Registrations therefor identified on EXHIBIT B-1 attached hereto (the "Works"); and

WHEREAS, Reynolds owns and desires to assign to Holdings, and Holdings desires to acquire from Reynolds, the Marks and the Works, and Registrations and applications therefor, all on the terms and conditions set forth hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Reynolds hereby assigns, transfers and conveys to Holdings the entire right, title and interest in the United States in and to (1) the Marks, together with the good will of the business symbolized by the Marks and the Registrations and applications therefor; and (2) the Works and Registrations therefor.

The rights granted herein include the right to bring suit or make any claim in Reynolds' name for prior or future infringement or misappropriation of rights in the Marks and the Works.
