After inspection of the certified extracts dated 09.07.1992 from Trade Registers HRB 466 and HRB 5856 of the Bonn District Court and of the certified extract dated 11.03.1993 from the Trade Register HRB 29373 of Dusseldorf District Court, I certify as follows:

- The company name of "Deutsche ATOCHEM Werke GmbH" residing in Bonn has been changed into "ATOCHEM Deutschland GmbH" by the shareholders' decision of 29.05.1990 and registration in the Trade Register on 02.11.1990.
- "ATOCHEM Deutschland GmbH" was merged with "CSL Chemische Werke Saar-Lothringen Gesellschaft mit beschränkter Haftung" residing in Perl (Merzig District Court HRB 3040) as a result of the merger agreement of 21.03.1991 and registration in the Trade Register on 13.12.1991. "CSL Chemische Werke Saar-Lothringen Gesellschaft mit beschränkter Haftung" is therefore the legal successor to "ATOCHEM Deutschland GmbH".
- As a result of the shareholders' decisions of 21.03.1991 and 13.12.1991, the registered office of "CSL Chemische Werke Saar-Lothringen Gesellschaft mit beschränkter Haftung" was moved from Perl to Bonn and the company name was changed to "Elf Atochem Deutschland GmbH". Registration in the Trade Register of Bonn District Court took place on 20.05.1992 under HRB 5856.

- As a result of the shareholders' decision of 16.11.1992, the registered office of "Elf Atochem Deutschland GmbH" was moved from Bonn (HRB 5856) to Düsseldorf. Registration in the Trade Register of Düsseldorf District Court took place on 05.03.1993 under HRB 29373.

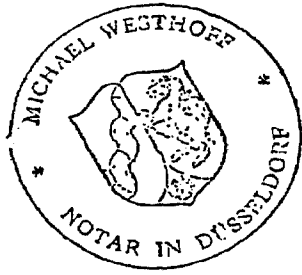
