

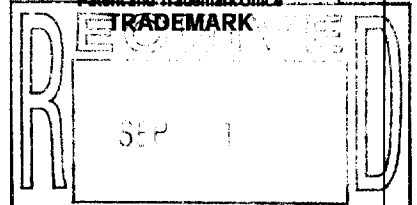


Meijer is desirous of acquiring the Mark and the corresponding United States Trademark Registration.
