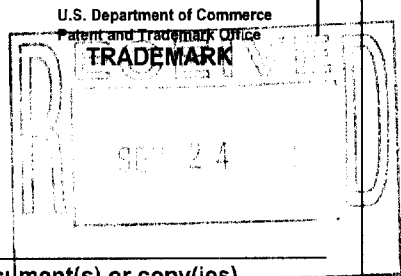

CERTIFICATE OF AMENDMENT  
OF THE CERTIFICATE OF CONSOLIDATION  
OF

THE AMERICAN HOME SEWING & CRAFT ASSOCIATION, INC.

UNDER SECTION 803 OF THE NOT-FOR-PROFIT CORPORATION LAW

WE, THE UNDERSIGNED, Paul N. Mackey and Joan Carter Campbell, being respectively the president and the executive vice-president and secretary of The American Home Sewing & Craft Association, Inc. hereby certify as follows:

1. The name of the corporation is THE AMERICAN HOME SEWING & CRAFT ASSOCIATION, INC.

2. The corporation was originally formed as a consolidation of the AMERICAN HOME SEWING COUNCIL, INC. and the NATIONAL HOME SEWING ASSOCIATION, INC. The certificate of consolidation of said corporation was filed with the New York State Department of State on the 16th day of February, 1978 under the New York State Not-For-Profit Corporation Law.

3. The consolidated corporation was originally named THE AMERICAN HOME SEWING ASSOCIATION, INC. The certificate of consolidation was amended to change the name of the consolidated corporation to THE AMERICAN HOME SEWING & CRAFT ASSOCIATION, INC. The certificate of amendment of the certificate of consolidation was filed with the New York State Department of State on the 14th day of August, 1990.

4. The corporation is a corporation as defined in subparagraph (a)(5) of section 102 of the not-for-profit corporation law.

5. (a) The certificate of incorporation is amended to

change the name of the corporation from The American Home Sewing & Craft Association, Inc. to the Home Sewing Association, Inc.

- (b) To effect the foregoing, Paragraph 1(d) of the Certificate of Consolidation is amended to read as follows:

"The name of the consolidated corporation is HOME SEWING ASSOCIATION, INC."

6. The amendment was authorized in the following manner:

By a vote of majority of all members entitled to vote thereon at a meeting of the members on September 28, 1997.

7. The Secretary of State is designated as agent of the corporation upon whom process against the corporation may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him is 1375 Broadway, New York, New York 10018.

8. The corporation is and shall continue to be a Type A Corporation as defined under section 201 of the not-for-profit corporation law.
