

THIS DEED OF ASSIGNMENT is made the 6th day of September 1999

BETWEEN

- (1) **WORLTEK INTERNATIONAL LIMITED**, a corporation organised and existing under the laws of the State of California, United States of America and of 1010 Corporation Way, Palo Alto, California 94303-4303, United States of America (the "Assignor"); and
- (2) **ASAT LIMITED**, a company incorporated in Hong Kong whose registered office is at 14th Floor, QPL Industrial Building, 138 Texaco Road, Tsuen Wan, New Territories, Hong Kong (the "Assignee").

WHEREAS:-

- (A) The Assignor is the registered proprietor of a trade mark (as hereinafter defined).
- (B) The Assignor has agreed to assign the said trade mark to the Assignee on the terms and conditions hereinafter appearing.

NOW IT IS HEREBY AGREED as follows:-

1. INTERPRETATION

1.1 In this Deed the following term shall have the following meaning:-

"Mark" means the registered trade mark in United States of America set out in Schedule 1 hereto.

1.2 Words importing the singular shall include the plural; words importing one gender shall include every gender; and references to persons shall include bodies corporate or unincorporate; and vice versa.

1.3 Clause headings are inserted for convenience only and shall be ignored in the interpretation of this Deed.

2. ASSIGNMENT

The Assignor as beneficial owner of the Mark HEREBY ASSIGNS the Mark with goodwill to the Assignee together with all the Assignor's rights and interests in respect of them.

3. WARRANTIES

The Assignor warrants to the Assignee that:-

- 3.1 the Assignor is the proprietor of the Mark and is entitled to assign its property, right, title and interest therein.
- 3.2 The Assignor is not aware of any act done or committed whereby the validity of any of the Mark may be impaired.

4. COVENANTS

The Assignor hereby covenants with the Assignee that the Assignor shall at its own cost and expense sign and execute such documents as may be necessary or appropriate for the purpose of registering the assignment granted herein to enable the Assignee to become registered as the proprietor of the Mark or otherwise to give effect to the provisions of this Deed.

5. GOVERNING LAW

The validity construction and performance of this Deed shall be governed by the laws of the Hong Kong Special Administrative Region and shall be subject to the non-exclusive jurisdiction of the Hong Kong Courts.
