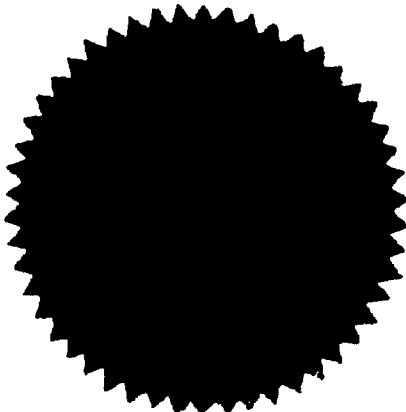


Article I of the Amended and Restated Articles of Incorporation of SimShop, Inc. is amended and restated as follows:
