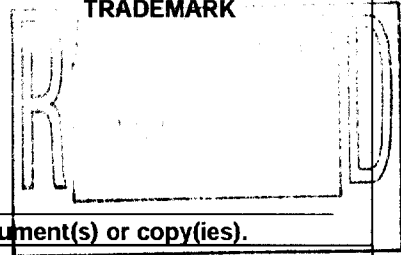



1. The name of the corporation is **ABS CORPORATION** and is duly organized, created and existing under and by virtue of the laws of the State of Arkansas.

2. The amendment to the Articles of Incorporation was adopted on August 28, 1998.

3. The Articles of Incorporation are amended as follows:

"Paragraph 'FIRST' of the Articles of Incorporation is hereby deleted in its entirety, and the following is substituted in lieu thereof:

'First: The name of the corporation is **BUDGETEXT Corporation.**'"


4. If an amendment provides for an exchange, reclassification or cancellation of issued shares and such provisions are not contained in the amendment itself, state the provisions for the implementation.

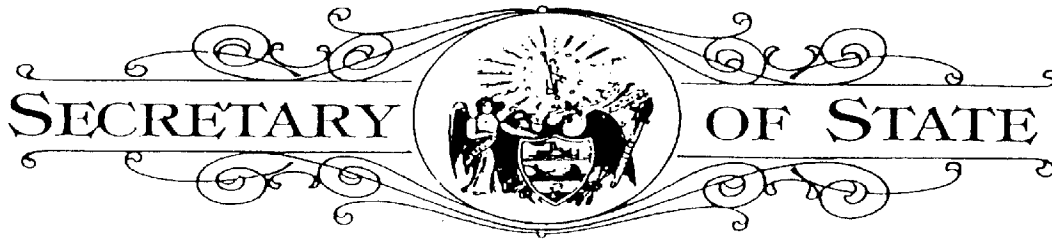

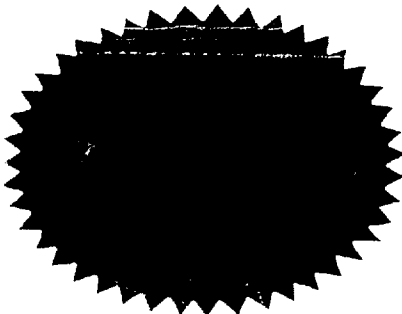
