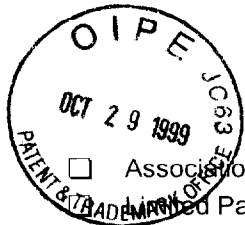


Assignor further assigns unto Assignee all right to sue for and to receive all damages accruing from past infringement of the United States Intellectual Property.
